## **ZEMS-1002 48 Hour Paramedic Refresher 4.8 CEUs**

This course meets the requirements of the Ohio Department of Public Safety (ODPS) 48-Hour Refresher Course, 4765-17-01.

## **ZEMS-1003 EMT Refresher - Basic 3 CEUs**

This course meets the requirements of the Ohio Department of Public Safety (ODPS) 30-hour EMT Basic Course, 4765-15-01. The College was notified following a site visit from the Ohio Department of Public Safety Division of Emergency Medical Services that national registry exam pass rates for the EMS Program are below minimum standards. As a result, the program has been placed on probation through January 31, 2026. The program continues to be accredited during this period.

## **ZEMS-1012 CCEMT-P Course 8 CEUs**

The course is designed to prepare paramedics and nurses to function as members of a critical care transport team. Participants will gain an understanding of the special needs of critical patients during transport, become familiar with the purpose and mechanisms of hospital procedures and equipment, and develop the skills to maintain the stability of hospital equipment and procedures during transport.

## **ZEMS-1015 EMS Instructor 8 CEUs**

This 80-hour training program is designed for individuals seeking EMS instructor certification. Students must pass a written knowledge test, possess current certification as a first responder or EMT with at least five years of on-the-job experience, and pass a practical exam.

## **ZEMS-1020 Stop the Bleed 0.3 CEUs**

Heartsaver AED course teaches the basic techniques of adult CPR and the use of the AED (automatic external defibrillator).

## **ZEMS-1023 EMT Basic 15 CEUs**

Comprehensive study of basic life support skills for an emergency medical technician-basic. Includes recognition of nature and seriousness of patient's condition or extent of injuries and assessing requirements of emergency care. Also includes lifting, moving, handling and transporting patients as part of pre-hospital emergency care system. The College was notified following a site visit from the Ohio Department of Public Safety Division of Emergency Medical Services that national registry exam pass rates for the EMS Program are below minimum standards. As a result, the program has been placed on probation through January 31, 2026. The program continues to be accredited during this period.

## **ZEMS-1041 BLS/CPR for Health Care 0.45 CEUs**

This course is for individuals who provide health care services to patients in a variety of settings. Learn CPR skills, including barrier device, bag, mask device and oxygen; use of an automated external defibrillator (AED); and relief of foreign body airway obstruction (FBAO). Students will receive a confirmation email with class information approximately three to five days before classes begin. Those who successfully complete the program receive a completion card.

## **ZEMS-1045 40 Hour EMT Refresher 3 CEUs**

CATALOG DESCRIPTION: Refresher course necessary for State of Ohio EMT recertification and National Registry written exam requirements to continue testing for certification. Students will integrate knowledge and skills learned in previous courses in order to demonstrate competence in EMT skills and techniques. American College of Surgeons or American College of Emergency Physicians approved trauma life support and National Association of EMT (NAEMT) medical life support standards. In the directed practice and field experience environment, they will demonstrate team leadership and integration with medical professionals.

## **ZEMS-1046 EMS Instructor – Bridge 0.8 CEUs**

This course is for any EMT or paramedic who must complete the National Registry psychomotor skills exam for the purpose of retesting and/or entrance into an EMS-I course.

**ZEMS-1047 EMS Skills Day**

**ZEMS-1050 ACLS 8 Hour Refresher**

**0.8 CEUs**

ACLS is an advanced, instructor-led classroom course that highlights the importance of team dynamics and communication, systems of care and immediate post-cardiac arrest care. It also covers airway management and related pharmacology. In this course, skills are taught in large group sessions and small, group-learning and testing stations in which case-based scenarios are presented.

**ZEMS-1051 BLS (CPR) Instructor**

**0.8 CEUs**

Class is for individuals currently certified at a BLS Provider Level and have been identified as having instructor potential, scored a 84% or above on the written test, and wish to become an instructor. The class is 1 day and requires the participant to agree to teach 2 classes a year to maintain instructor certification. The course requires student to purchase an Instructor and Provider Handbook. Also requires the student to be monitored teaching a class prior to receiving an instructor certification card.
