## **ZISO-1039 Certified Quality Auditor (CQA) Refresher** 2.4 CEUs

This eight-week course prepares Quality Professionals for the exam that leads to Certified Quality Auditor (CQA) certification from the American Society for Quality (ASQ). Sample questions will be reviewed throughout the course to give students a feel for the exam.

As the most commonly used risk analysis method in the automotive industry, PFMEA helps suppliers predict and prevent failures in part production processes.
