

# ADVANCED LAW ENFORCEMENT (ZLAW)

## ZLAW-1002 Police Urban Mountain Biking 4 CEUs

This course introduces the novice or experienced police bicyclist to the latest techniques in basic patrol cycling. This physically and mentally demanding course combines emergency vehicle operations for bike officers with patrol procedures, tactics, night operations, scenarios, basic bike maintenance and on-the-road repairs. Learn to ride like a pro, avoid crashes and use your bike to foil the bad guys every time. Off-road riding and bike-specific live-fire exercises may be added at the instructor's discretion. Participants must attend all class dates and pass all examinations to be awarded the International Police Mountain Bike Association (IPMBA) Certificate of Completion. ## ZLAW-1062 Court Officer Bailiff Firearms Academy 4 CEUs

This Ohio Peace Officer Training Commission 40-hour training academy fulfills the basic training requirement per OAC Section 109:2-5-05(A) for bailiff, deputy bailiff, probation or parole officer, tactical medical professional and multicounty / multi-jurisdictional jail corrections officer that carries a firearm in the course of their official duties, or an employee of the Department of Youth Services who is authorized to carry a firearm while on duty may attend Court Officer Basic Training Academy.

*Prerequisite(s): All candidates must be employed as a Bailiff, Deputy Bailiff, Probation or Parole Officer, Tactical Medical Professional, a multicounty / multi-jurisdictional jail corrections officer, or the Department of Youth Services.*

## ZLAW-1124 Private Security Firearms Qualification (20 hours) 2 CEUs

This 20-hour qualification course for individuals working in the field of private security is designed to make the officer compliant with 4749.10 Ohio Revised Code. Topics include course of fire, rules of engagement and use of force. You must bring a semi-automatic weapon as well as holster, ammo, magazines and pouches. This can be provided if needed. • Background checks and/or department letter required 14 business days prior to training. • Participants who miss any part of the training will not pass the course nor will they receive certification.

## ZLAW-1173 Private Security Firearms Requalification 0.4 CEUs

This qualification course for individuals working in the field of private security will make security officers compliant with 4749.10 Ohio Revised Code. Topics include course of fire, rules of engagement and use of force. You must bring a semi-automatic weapon as well as holster, ammo, magazines and pouches. This can be provided if needed. • Participants who miss any part of the training will not pass the course nor receive certification. • Background checks and/or department letter required 14 business days prior to training. • OPOTC certification must be submitted to PrivateSecurity@tri-c.edu prior to the start of class.

## ZLAW-1177 First Aid/CPR/AED Certification 0.8 CEUs

Basic level first aid and one-person CPR course intended to provide the knowledge and skills necessary to minimize consequences of injury and sudden illness until professional medical help arrives.

## ZLAW-1181 Advanced UAS (Drone) Operations for Public Safety 1.4 CEUs

This two-day training course helps public safety UAS pilots take their skills to the next level. Participants engage in lectures and hands-on learning during the day and sharpen their piloting skills at the Simulated Scenario Village in the evening. Topics include: Thermal sensor operations Search tactics and strategies Night operations Tactical operations (SWAT, interior search, etc.)

## ZLAW-1188 Introduction to Drone Operations 4 CEUs

This one-week drone operator course will introduce first responders to drone technology, including its capabilities and uses in law enforcement and other emergency response situations. The course will provide hands-on experience via simulation. First responders will have an understanding of how and when to utilize drones from emergency and homeland security situations. Participants must be law enforcement, fire or other type of first responder.

## ZLAW-1191 Advanced Emergency Night Driving 0.8 CEUs

This comprehensive 8-hour course is specifically designed for law enforcement personnel only and requires department approval. It includes both classroom and hands-on training in the specific hazards of nighttime illumination, multitasking, vehicle dynamics, Ohio Revised Codes, police liability, and decision-making skills. It's designed to prepare U.S.-based students to take a national exam that leads to job placement and combines demo and hands-on training in the classroom, including: Practice handling single/multiple simulated calls with scenarios in law, fire and EMS using 911 dispatch software Exercises to learn to read maps effectively Keyboarding, listening and responding to actual 911 and nonemergency calls Skill-building exercises using computer-aided dispatch (CAD) Basic introductory course to emergency medical dispatch (EMD) Skills assessment exam to prepare students for Dispatcher Civil Service Exam Training on how to mitigate active threats Incident Command Training with FEMA ICS 100

### **ZLAW-7046 Police Motorcycle Operator Course**

#### **8 CEUs**

This comprehensive 80-hour course is specifically designed for law enforcement personnel only and requires department approval. It includes both classroom and hands-on training in specific operation of police motorcycles. It focuses on slow speed maneuvering, tight turns and emergency braking.

*Prerequisite(s): Current law enforcement officer Basic motorcycle-handling skills Good physical condition Motorcycle endorsement Students must provide the following equipment: Department motorcycle Over-the-ankle footwear Long pants (no holes) and long-sleeved shirt or jacket Full-fingered gloves Eye protection DOT or SNELL-certified helmet Repairs: In the event of clutch lever or brake lever damage, departments must supply parts. Levers will be repaired on-site. Please note: Dress for the weather. Classes and activities take place rain or shine. ### **ZLAW-7051 Police Motorcycle Instructor Course**

#### **12 CEUs**

This comprehensive 120-hour course is specifically designed for law enforcement personnel only and requires department approval. It combines both classroom and hands-on training and all candidates must be certified as a police motorcycle operator prior to attending the Police Motorcycle Instructor course.

### **ZLAW-7054 IPMBA E-Bike Training Course**

#### **0.8 CEUs**

This eight-hour e-bike training module uses a combination of lectures, skill practice and isolation drills to help public safety cyclists transition their fundamental cycling skills from conventional bicycles to e-bikes. E-bikes are faster, heavier and less maneuverable than conventional bicycles; therefore, public safety cyclists must successfully complete the applicable IPMBA Public Safety Cycling course prior to registration. Note: This training module does not support out-of-class electric vehicles (OCEVs) that exceed the maximum legal speed limit for e-bikes.
