

# FIRE-ADVANCED TRAINING (ZEFR)

## **ZEFR-1000 Fire Safety Inspector 8 CEUs**

The Fire Safety Inspector Course is designed to provide firefighters with the knowledge, skills, and abilities necessary to conduct fire and life safety inspections in Ohio, in accordance with O.A.C. 4765-20-03 and NFPA 1031. The course will contain both IFSAC Fire Inspector I and Fire Inspector II necessary information. Students will gain valuable hands on experience from industry professionals. Topics covered will include but not limited to prevention through education in: roles and responsibilities, fire prevention, application of the code, code interpretation, testifying, plan review, code revision process, fire protection systems, enforcement action, customer service, and evaluation of code compliance in an assortment of occupancies. Students must attend all classes and pass all written and practical exams to successfully complete the course. For certification, students must pass the Division of EMS Fire Safety Inspector written exam with a minimum score of 70%, and all applicable practical skills.

## **ZEFR-1001 Fire Instructor Trainer 7 CEUs**

## **ZEFR-1004 Firefighter's Physical Agility Prep Course 1 CEUs**

## **ZEFR-1136 Fire & EMS Instructor Update 0.6 CEUs**

The Instructor Update is designed for the State of Ohio Fire/EMS Instructor recertification. This course covers current and new teaching methods and techniques. The update meets the six-hour continuing education recertification requirements for the state of Ohio.

## **ZEFR-1137 Firefighter 2 12 CEUs**

Course meets and exceeds the certification requirements established in the Ohio Revised Code for FF 2 and the training and educational standards identified in NFPA 1001.

## **ZEFR-1141 Firefighter 1 24.8 CEUs**

This course meets the certification requirements established in the Ohio Revised Code for Firefighter 1.

## **ZEFR-1150 Volunteer Firefighter Course 3.6 CEUs**

This course prepares new volunteers for safe participation in a live burn. The course promotes firefighter safety and develops realistic objectives that can be accomplished in the 36 required hours of instruction for basic ventilation while eliminating the portable fire extinguisher training requirement.

## **ZEFR-1162 Fire Officer I 8 CEUs**

This course prepares the line fire officer or aspiring firefighter to perform their job duties by giving them knowledge and skills needed to: understand leadership and management theories, lead a team, understand community relations and risk reduction, understand and perform pre-incident planning and code enforcement, command initial emergency operations and understand safety and risk management.

## **ZEFR-1163 Fire and Emergency Services Instructor I and II 7 CEUs**

This course is designed for firefighters with five years of experience who wish to complete their instructor training with a combination of concentrated classwork and online learning.

## **ZEFR-1165 Origin and Cause - Basic 8 CEUs**

This course introduces students to the basic concepts of origin and cause, utilizing classroom lecture and hands-on techniques.

## **ZEFR-1166 Origin and Cause - Advanced 4 CEUs**

This extensive hands-on course provides the in-depth knowledge and skills necessary to thoroughly investigate fires from fire scenes to the courtroom, as outlined in NFPA 921. Includes fire dynamics, motives, fire scene fatalities, scene documentation, evidence, case preparation and testimony. Students engage in a hands-on investigation that includes investigating, documenting and collecting evidence from a fire scene, case preparation.

## **ZEFR-1171 Fire Officer II 8 CEUs**

This course prepares the line fire officer or aspiring firefighter with the knowledge and skills needed to: apply leadership principles, manage community risk reduction programs, determine fire causes, manage major fire incidents, prepare for promotion and create a self-development plan.

**ZEFR-1186 Live Fire Instructor, NFPA 1403 Initial certification**  
**2.4 CEUs**

This three-day advanced training course is for certified fire instructors who want to facilitate a live burn training exercise per NFPA 1403 Live Burn Training. It will encompass a classroom session for NFPA 1403 standards and live fire scenarios at a mobile fire training unit, along with an acquired structure burn with students filling the role of lead instructor, ignition, safety, accountability and crew leaders.

**ZEFR-1190 Structural Collapse Operations, NFPA 1006**  
**3.2 CEUs**

This course meets all NFPA 1670 guidelines and enables rescue teams to operate safely and effectively in structural collapse incidents involving the collapse or failure of lightframe, ordinary construction, un-reinforced and reinforced masonry construction. At the conclusion of this course, students will understand the procedures for recognizing unique collapse or failure hazards, and for stabilizing and shoring up structures. An increased emphasis on rescue will include search-and-rescue techniques intended to locate victims trapped inside and beneath collapse debris, discussion about procedures for accessing victims trapped inside and beneath collapse debris, procedures relevant to extrication operations involving packaging, and treating and removing victims within and beneath collapse debris.

**ZEFR-1191 Swiftwater Operations, NFPA 1006**  
**3.2 CEUs**

At the end of this course the student will know the hazards of moving water and be able to perform operation-level swiftwater rescues.

**ZEFR-1193 Rope Operations, NFPA 1006**  
**3.2 CEUs**

This program meets or exceeds the requirements for NFPA 1006. This 32-hour program includes classroom and practical training, including the completion of an assignment while suspended from a rope rescue system, moving a victim, functioning as a litter tender, selecting and constructing a system, and directing a team in the operation of a system in a high-angle environment.

**ZEFR-1194 Confined Space Operations and Technician, NFPA 1006**  
**3.2 CEUs**

This 24-hour program includes classroom and practical training coordinating, performing and supervising complex confined space rescue operations. Topics include hazard identification, equipment usage, confined space pre-planning, incident action plan development and implementation, complex rescue considerations, corrective measures for controlling hazards and advanced rescue techniques.

**ZEFR-1195 Rope Rescue Technician, NFPA 1006**  
**3.2 CEUs**

This program meets or exceeds the requirements for NFPA 1006 Standard for technical Rescuer Professional Qualifications. This 32 hour program includes classroom and practical training including completing an assignment while suspended from a rope rescue system, moving a victim, functioning as a litter tender, selecting and constructing a system, directing a team in the operation of a system in a high angle environment.

**ZEFR-1196 Truck Company Operations**  
**0.6 CEUs**

This class will focus on safe and effective use of aerial apparatus and truck company operations.

**ZEFR-1200 Fire Officer III & IV**  
**8 CEUs**

This project-based course prepares future chief officers as they transition from company officers and become problem solving leaders for their organization. Some of the topics include leadership, professional development, communications, legal issues, human resources, intergovernmental relations, budget and finance issues, strategic planning, managing the code enforcement process, emergency management, community risk reduction, and response planning.

**ZEFR-1201 EMS to Fire Instructor Bridge Day**  
**0.8 CEUs**

This course serves as a bridge for EMS instructors to acquire a knowledge base in Fire instruction.

**ZEFR-1203 Advanced Fire Continuing Education: 8 CEUs**  
**0.8 CEUs**

This course enhances the knowledge and skill levels of incumbent firefighters.

**ZEFR-1205 NFPA 1006 Common Passenger and Heavy Commercial Vehicle Rescue Technician**  
**4 CEUs**

The NFPA 1006 Common Passenger and Heavy Commercial Vehicle Rescue Technician course acquaints students with techniques used in auto extrication. Students will become familiar with the different classifications and characteristics of vehicles and machines and will also become familiar with the different tools used in extrications, stabilization of the vehicle/machine, disentanglement of patients and initiating patient care. This course covers the incident command system and how to terminate the incident when finished.

**ZEFR-1206 Trench Operations, NFPA 1006  
3 CEUs**

The scope of this course is to prepare local responders to operate as a member of a regional team with the NIMS at a CBRNE (chemical, biological, radiological, nuclear, or explosive) WMD event requiring statewide response, and requiring a non-intersecting trench rescue. The trench rescue operations course has been designed in accordance with NFPA 1006, Standard for Technical Rescue Professional Qualifications. This course pertains to trench rescues involving injured or entrapped persons. The class covers the federal and state regulations, use of specialized equipment for atmospheric monitoring, emergency shoring systems, victim extraction and employment of rescuer constructed retrieval systems. Special emphasis will be given to rescuer safety and scene evolutions involving various trench rescue problems. Written and practical skills testing will be conducted at the completion of the course.

**ZEFR-1208 Firefighter I & II  
26 CEUs**

The course meets the training and education standards for Firefighter I and II as identified in the National Fire Protection Association (NFPA) Standards, NFPA 1001.

**ZEFR-1209 Surface Ice Rescue  
0.8 CEUs**

Surface Ice Rescue is an eight-hour training program that prepares first responders from all public safety disciplines to respond to and carry out surface ice rescues. Students receive an introduction to ice hazards and formation, equipment selection, medical considerations and the application of proven rescue methods and techniques. Successful completion is measured in class participation, a final written exam and surface and in-water skills testing.

**ZEFR-1213 Firefighter Certification Reciprocity Course  
5 CEUs**

This course covers Firefighter I/II knowledge and skills objectives identified by the Ohio Department of Public Safety Division of EMS (ODPS/EMS); state skill testing; and the State of Ohio Certification Examination. Students must attend all required lectures and labs (practical drills). State skill testing is contingent upon approval by the ODPS/EMS of the completion of all knowledge and skills objectives, and the certification exam is contingent upon the successful completion of the required skills testing.

**ZEFR-7041 Live Fire Instructor, NFPA 1403 Recertification  
0.8 CEUs**

This eight-hour advanced training course is for fire instructor's recertification. The course includes a classroom session for NFPA 1403 2018 standards updates; live fire scenarios at a fixed facility; propane quad; and a mobile fire training unit with students filling the roles and completing the JPRs of instructor-in-charge, safety officer, ignition officer, observer and team leader.

**ZEFR-7047 ODPS/EMS State Certification Exams

**ZEFR-7048 Company Officer Workshop  
1.6 CEUs**

This course is designed for first level officers, newly promoted officers, and acting officers of the Fire Department. This intensive two-day workshop covers aspects of the fire officer's job, providing a range of resources to assist in leadership development, decision-making, training, conflict resolution, counseling while mindful of generational differences, and fire ground operations.
